8. Committee Reports

8.1 Governance Committee – D. Charlton

- The committee received the legal review of the library's bylaws and will now move forward with their review
- There will be a package ready for the Board to review in September
- The committee continues to work on streamlining governance policies

8.2 Finance and Resources Committee – J. Murphy

• The committee continues to review financial policies as per their workplan and will be consolidating several of them into a financial controls policy in an effort to streamline the existing financial policies

9. CEO Report – K. Kipfer

In her written submission distributed with the board package, K. Kipfer highlighted the following:

 WPL partnered with the Accessibility Centre for a comprehensive self-evaluation of accessibility across the organization. Involving diverse staff, the sessions deepened awareness of accessibility needs. A report with recommendations is expected soon and will guide updates to WPL's accessibility plan and inform the new McCormick design



- WPL is actively contributing to two significant cross-sector projects:
 - **1) Emotional Resilience in Libraries**: A study on emotional labour led by Hamilton and Burlington libraries
 - **2) CULC National Impact Survey**: A Canada-wide customer feedback initiative to document the social impact of libraries. WPL reached its response quota quickly and received highly positive unsolicited feedback from customers
- Outreach programming at Monica House has successfully transitioned from offsite to in-library engagement. Young mothers have now received library cards and are attending on-site programs, reflecting WPL's successful efforts in meeting people where they are and fostering lasting community relationships
- New special lending items have been added to the collection, including keyboards,
 pickleball sets, and C pen readers. WPL also received a significant donation of 1800sera local photos, which will be curated in partnership with the City of Waterloo
 Museum. The City has approved the next phase of relocating the museum to the
 Carnegie library, opening new opportunities for joint initiatives

10. AMCC Update – K. Kipfer

Phase 1 of the McCormick (AMCC) renovation has begun with no current impact on library services. Plans are in motion to maintain holds pick-up, browsing, programming, and computer access during future closures, potentially via book vending machines and holds lockers. Efforts are also underway to retain and reuse shelving, furniture, and supplies, with a significant collection storage strategy being developed.
